Re: Natural Gas Supplier License of Convenient Ventures, LLC d/b/a EnergyObjective d/b/a Shipley Energy Advisors

Dear Mr. Stewart:

On January 25, 2023, Convenient Ventures, LLC d/b/a EnergyObjective (Convenient Ventures) filed a request with the Commission to change the name on its license to provide natural gas services, as a broker/marketer, to Convenient Ventures, LLC d/b/a EnergyObjective d/b/a Shipley Energy Advisors.

Currently, Convenient Ventures is licensed as Convenient Ventures, LLC d/b/a EnergyObjective as a broker/marketer to small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division, Philadelphia Gas Works, UGI Utilities, Inc.<sup>2</sup>, and Valley Energy, within the Commonwealth of Pennsylvania.

Convenient Ventures has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission.

Therefore, the Commission approves, by this Secretarial Letter, the change of Convenient Ventures, LLC d/b/a EnergyObjective's name on its license for the provision of natural gas services as a broker/marketer.

The Secretary's Bureau will issue a new license to Convenient Ventures, LLC d/b/a EnergyObjective d/b/a Shipley Energy Advisors the right to begin to offer, render, furnish, or supply natural gas services as a broker/marketer to small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and

governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, UGI Utilities, Inc., and Valley Energy, within the Commonwealth of Pennsylvania.

The Secretary's Bureau and the Bureau of Administration, Financial and Assessments will update the company's name in their computer systems and lists, as appropriate, to be Convenient Ventures, LLC d/b/a EnergyObjective d/b/a Shipley Energy Advisors.
