Re: Electric Generation Supplier License of Telco Pros LLC d/b/a TPI Efficiency Consulting

Dear Ms. Burns:

On January 3, 2023, Telco Pros Inc. d/b/a TPI Efficiency Consulting (Telco Pros Inc.) filed a request with the Commission to change the name on its license to provide electric generation services, as a broker/marketer, to Telco Pros LLC d/b/a TPI Efficiency Consulting (Telco Pros LLC).

Currently, Telco Pros Inc. is licensed as Telco Pros Inc. d/b/a TPI Efficiency Consulting as a broker/marketer to residential, small commercial (25 kW and under demand), large commercial (over 25 kW demand), industrial, and governmental customers in all of the electric distribution company service territories throughout the Commonwealth of Pennsylvania.

Telco Pros LLC has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission. Furthermore, Telco Pros LLC has provided an update to its financial security instrument reflecting its new name.

Therefore, the Commission approves, by this Secretarial Letter, the change of Telco Pros Inc. d/b/a TPI Efficiency Consulting's name on its license for the provision of electric generation services as a broker/marketer.

The Secretary's Bureau will issue a new license to Telco Pros LLC d/b/a TPI Efficiency Consulting the right to begin to offer, render, furnish, or supply electric generation services as a broker/marketer to residential, small commercial (25 kW and under demand), large commercial (over 25 kW demand), industrial, and governmental customers in all of the electric distribution company service territories throughout the Commonwealth of Pennsylvania.

The Secretary's Bureau and the Bureau of Administration, Financial and Assessments will update the company's name in their computer systems and lists, as appropriate, to be Telco Pros LLC d/b/a TPI Efficiency Consulting.
