Re: Electric Generation Supplier License of BP Energy Retail Company LLC

Dear Ms. Briscoe:

On December 21, 2022, EDF Energy Services, LLC (EDF Energy Services) filed a request with the Commission to change the name on its license to provide electric generation services, as a supplier, to BP Energy Retail Company LLC (BP Energy Retail).

Currently, EDF Energy Services is licensed as EDF Energy Services, LLC as a supplier to small commercial (25 kW and under demand), large commercial (over 25 kW demand), industrial, and governmental customers, as well as residential and small commercial (limited to mixed meters) customers, pursuant to the Commission's Secretarial Letter dated March 25, 2011 at Docket No. M-2009-2082042, in all of the electric distribution company service territories throughout the Commonwealth of Pennsylvania.

BP Energy Retail has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission. Furthermore, BP Energy Retail has provided an update to its financial security instrument reflecting its new name.

Therefore, the Commission approves, by this Secretarial Letter, the change of EDF Energy Services, LLC's name on its license for the provision of electric generation services as a supplier.

**The Secretary's Bureau will issue a new license to BP Energy Retail Company LLC the right to begin to offer, render, furnish, or supply electric generation services as a supplier to small commercial (25 kW and under demand), large commercial (over 25 kW demand), industrial, and governmental customers, as well as residential and small commercial (limited to mixed meters) customers, pursuant to the Commission's Secretarial Letter dated March 25, 2011 at Docket No. M-2009-2082042, in all of the electric distribution company service territories throughout the Commonwealth of Pennsylvania.**

**The Secretary's Bureau and the Bureau of Administration, Financial and Assessments will update the company's name in their computer systems and lists, as appropriate, to be BP Energy Retail Company LLC.**
