NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper or required by carrier. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier. Supervisor hourly rates will be charged at \$3.00 above additional men hourly rate.

NOTE 6 - Tolls and/or parking permits/tickets incurred by the carrier when transporting the shipment will be the responsibility of the shipper and added to the final charges.

NOTE 7 - <u>HANDLING FEE</u> - Carrier will add a 3% handling fee to the final charges when the customer chooses to pay with a credit card. NOTE 8 - <u>WAIVER OF MINIMUM CHARGE - CARRIER CONVENIENCE</u> - Carrier will not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time required to complete the move plus applicable travel charge.

▲ NOTE 9 - <u>ADMINISTRATIVE FEE</u> - An administrative fee of \$50.00 will be added to the total cost of each shipment. This fee will apply to shipments transported 40 miles or less and shipments transported in excess of 40 miles.

A In lieu of applicable rates by county in tariff, Tristate 51-W, the following rates will apply at all points within Pennsylvania:

NOTE 6 - LABOR RATE (Item 120) - Labor Rates shown for Northampton County will apply for all counties in Pennsylvania.

NOTE 7 - ADDITIONAL TRANSPORTATION CHARGE (Item 160) - Rates shown under Schedule 2 will apply for all counties in Pennsylvania.

▲ NOTE 8 - STORAGE-IN-TRANSIT AND WAREHOUSE HANDLING CHARGES (Item 200 and Section 3) - Rates shown for Northampton County will apply for all counties in Pennsylvania when storage-in-transit is at the carrier's facility in Easton PA.

A NOTE 9 - EXTRA PICKUP AND/OR DELIVERY (Item 230) - Rates shown under Schedule D will apply for all counties in Pennsylvania.

A NOTE 10 - OVERTIME LOADING/UNLOADING Item 240) - Rates shown for Northampton County will apply for all counties in Pennsylvania.

▲ NOTE 11 - ELEVATOR, STAIR CARRY, EXCESSIVE DISTANCE (Item 260) - Rates shown under Schedule D will apply for all counties in Pennsylvania.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.
