She will provide light packing of boxes and personal items for loading. She will make sure all items are secure, bubble wrapped, and taped for loading on the truck.

I spoke with Kelly Keiser who advised that she does not have her W-2s as her employment with Fritz Moving Company was over 10 years ago and they are no longer in operation. She advised that she only has records for the past 7-10 years and during that time she was a stay-at-home Mom.

2. Justin Steckbeck will be our Head Supervisor. His duties will include driving our truck, maintaining the truck, moving larger items, meeting with customers and assisting with writing estimates and preparing the customers for their moving day.

****Tribe Moving LLC will primarily work in retirement communities (Downsizing) transporting items from one building to another. There will internal moves as well as external moves to storage units, family homes, and auction houses.**

My name is Mark Mountz, and I am owner of Tribe Moving with my wife, Carrie. I have co-owned and worked for Mountz Disposal Service for 25 years. I have been head supervisor, driver, and owner during that time. My everyday job duties include using my Class B commercial Driver license to operate our trash trucks, recycling trucks, and enclosed trailers. Along with driving, I also plan and manage routes for our employees, bid commercial and residential jobs, and handle customer service calls. During Covid (2020) I was working with a few retirement communities disposing of soiled items from within their communities. While I was working in the communities, (as one of the few people allowed in the buildings due to shut down) I would be asked to relocate furniture and items within the building or to the next building over. I used moving carts and dollies to move personal belongings within the building/buildings as a laborer. I often would pack and move entire units from one floor to another floor within the buildings. I moved customers personal belongings to storage units within the facility with use of my trailer. This work continued, and we continue to get more and more requests for additional moving services. In April 2022, we decided to name our business and start researching how to expand our company. I have worked as a laborer for many people moving and assisted with loading and unloading their rented vehicles. At this time, we would like to add more team members and offer internal and external moving services. We have continued to do internal moves for the past 3 years but need to expand at this time. We are working hard to develop the best crew to handle the needs of our customers.

I will train every employee that becomes part of my team as I have thus far in my career. I will offer 2 full weeks of driving, packing, and moving training for any of my employees.


