NOTE 6 - When a gun safe is included in the shipment, a charge of \$150.00 per gun safe in addition to all other applicable charges will apply. When a piano is included in the shipment, a charge of \$250.00 per piano in addition to all other applicable charges will apply. When other articles deemed by the carrier to be bulky items are included in the shipment, a charge of \$100.00 per item in addition to all other applicable charges will apply. Carrier reserves the right to refuse transport of certain items to size and weight.

NOTE 7 - When packing is requested or required, the container cost will be based on charges shown in Item 310 of Tristate 50-T and Item 115 of Tristate 51-W. Charges for packing and/or unpacking will be based on a flat fee of \$100.00 per vehicle used plus a cost of \$60.00 per hour for driver or additional packer. Packing/unpacking labor hours to be based on the total time from when the vehicle, driver and packer(s) leave the carrier's terminal until their return to the carrier's terminal at the completion of the job. Travel time to and from the job site may be calculated, in advance, using computer software designed to calculate mileage and travel time such as Google Maps, MapQuest or TruckRouter.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 20 miles	1 hour
21 - 40 miles	1 1/2 hours
41 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.
