Responding to the (so-called) Aqua New Matter

- A.) To clearly state, the gas feeding the hot water heater was coming from another gas meter, as foreign load.
- B.) On the prior, Aqua High Bill dispute Report, (dated 5/2/19) Aqua claims to have six accounts at the property, which is not the truth.
- C.) Re: #12.....The foreign load issues were not timely addressed nor were they corrected. This is discrimination in safety and the same for service. So far as justification being a concern, the case was judged in error, this is also discrimination.
- D.) Re: # 13.....Chapter 15 of the code instructs the company (aqua) to pursue collection from the building owner, not the tenant.
- E.) Re: #14.....The PUC lacks jurisdiction to conduct a federal jury trial hearing. But this is the requested relief, sought here.

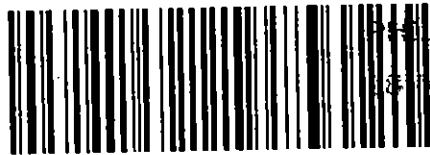

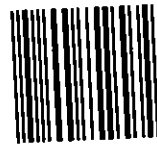
