

Re: C-2022-3033942 Tearpock-Martini v. UGI Utilities, Inc.

This is an inquiry to the PUC on status of above referenced file by the Complainant.

- FTM Formal Complaint filed on UGI Harassment 07 20 22
- Motion for Judgment by UGI filed 10 17 22
- Reply to Motion for Judgment by FTM 11 05 22
- Case was assigned to Honorable Judge Collins who scheduled an informal discussion which took place on 11 17 22.
- Also, on November 2, 2022, Commission had issued a Hearing Notice and Prehearing Order. Hearing was scheduled for December 13, 2022.
- On November 9th, 2022 Complainant sent an email to Matt Homsher in the legal department in need for clarification and to understand the process. Attorney McHugh for UGI requested the same clarification to Judge Collins. Judge Collins addressed both concerns during the informal discussion. Judge Collins expressed that she would require more time on the Motion for Judgment and would be cancelling the Hearing scheduled for December 13th since it was incorrectly scheduled.

Judge Collins in email made clear the nature of the informal discussion would remain informal. The purpose "will simply be to clarify issues - not to litigate the matter." Her thoroughness is appreciated.

It is now March 23, 2023. I have not heard anything and would appreciate a status update.

I have called the PUC on several occasions leaving messages on answering machines in the Legal Department and in the ALJ Department and no one has returned my phone calls. I have many matters of business to attend to and am attempting to keep my calendar open and available for scheduling by the PUC as well.

I should add that in this interim period additional trespass has occurred at my property causing significant damages to my Magnolia tree and separate Complaints have been filed.

I trust someone will reply and address this inquiry.


