We received instructions to upload the revised Attachment B and this cover letter in an email from Jeremy Haring and Lee Yalcin, along with the Dec Order and Mar Order documents. Attached is the updated Attachment B for the Somerset Gas Gathering ACT127 registration that was submitted via the PA PUC e-filing portal.

We made one adjustment to the McKean County Transmission mileage from our original CY2022 submittal so that the mileage reflects actual conditions as we continue to improve mapping/GIS of this system. The total mileage is the same, but actual conditions are that there are 9.2-miles of Class 1 Transmission and 1.4-miles of Class 2 transmission, which made our mileage in the "Class 2 Gathering/Transmission & Distribution" column now a total of 7.4-miles.
