Please provide evidence for ~~Mike Soto~~ that shows at least two years' experience with a licensed household goods carrier. We will need to see W-2s of ~~Mike Soto's~~ work experience, as well as a notarized letter from ~~Mike Soto's~~ previous employer(s) verifying said employment.


"Blue X's" are to change the name listed from Mike Soto to Cory Mayo. Cory Mayo is our current best prospect to be GM. He has set a goal to provide said information listed above by this upcoming Tuesday (03/28/23).

## Contract of Employment

I, Cory Mayo, agree to stay with T7 Moving and Transportation Ltd. for two full years, starting the date the company receives its PUC code. I will be taking over this responsibility from King Jenkins; to which he has agreed via a Separation Agreement also sent to the PUC. My duties will consist of, at the least, overseeing all jobs that T7 Moving and Transportation Ltd. takes part in, ensuring a quality of work that meets or exceeds the industry standard, checking that all proper and prudent safety measures are followed as related to the safe transport of used household goods and the proper operation of commercial vehicles; and I will train the team to meet such standards. I will engage in on-the-job duties with the team at T7 Moving and Storage Ltd., and my work week will not stop while there are still jobs to be performed.

Should T7 Moving and Transportation Ltd. shut down, or stop doing business for any reason, my role as a general manager will be terminated, and I will not be obligated any further payment from T7 Moving and Transportation Ltd., or its owner (Sean Keehn), due to the 2 year term or for any other reason. My payments shall be \$300 a month in addition to what I already make on the job. Payments will begin once T7 Moving and Transportation is licensed and permitted to do intrastate work within PA, and will cease if for any reason T7 Moving and Transportation loses its license.

The summation of my experience in the moving industry is greater than two (2) years. I shall oversee all operations in T7 Moving and Transportation Ltd. for at least two years, at which time the obligation is finished, and another contract may or may not be furnished.
