Pursuant to the Commission-approved Joint Petition for Settlement, Paragraph 23 in the above matter, Audubon Water Company (“Audubon”) reports that it is maintaining the required log of valve exercising. Audubon will continue exercising valves and maintaining the required log.

Valve exercising during April 1, 2022 through present identified one valve that was not able to be repaired immediate. Audubon will try to repair the valve again this spring. If the valve cannot be repaired, it will be replaced. Audubon also notes that it has identified two other valves that require further investigation, which Audubon will also address this spring and repair or replace if and as necessary.
