This filing is for a **REDUCTION** in local hourly rates.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 5 - When bulky items, such as, Pianos & Organs, Gun Safe, Pool Table or Hot Tub are included in the shipment, an additional fee of **\$100.00** per item will be assessed in addition to all other applicable charges.

NOTE 6 - **PRIOR DAMAGE** - TWO MEN AND A TRUCK® will not be liable for damages incurred prior to acceptance of goods or after delivery is made and the customer has had reasonable time to inspect the goods.
