Request for Extension of Time to File the Revised 2023 USECP

Dear Ms. O'Dell:

On January 12, 2023, the Pennsylvania Public Utility Commission (Commission) entered an Order (*January 12<sup>th</sup> Order*) which directed Philadelphia Gas Works (PGW) to, *inter alia*, file a revised 2023-2027 Universal Service and Energy Conservation Plan (2023 USECP) consistent with the Order within thirty (30) days (*i.e.*, by February 13, 2023). *January 12<sup>th</sup> Order* at 94, OP#2.


On January 18, 2023, PGW filed a Petition (January Petition) requesting a 60-day extension for submitting its Revised 2023 USECP. Petition for Extension at 1. On January 27, 2023, PGW filed a Petition for Reconsideration regarding the disposition of its 2023 USECP set forth in the Commission's *January 12<sup>th</sup> Order*. On February 9, 2023, the Commission entered an Order (*February 9<sup>th</sup> Order*) that approved the Petition for Extension and granted the Petition for Reconsideration, pending review of, and consideration on, the merits of the Petition for Reconsideration. *February 9<sup>th</sup> Order* at 2-3.

On March 16, 2023, the Commission entered an Order (*March 16<sup>th</sup> Order*) that granted the Petition for Reconsideration in part and denied the Petition for Reconsideration in part. The *March 16<sup>th</sup> Order*, *inter alia*, directed PGW to file its Revised 2023 USECP within 30 days (*i.e.*, by or before April 12). *March 16<sup>th</sup> Order* at 25, OP #7. On March 27, 2023, PGW filed a Petition (March 27<sup>th</sup> Petition) requesting an extension until June 12, 2023, to file its Revised 2023 USECP as directed by the Commission in the *March 16<sup>th</sup> Order*. PGW states that work on the Revised 2023 USECP is underway, however, it needs additional time to incorporate the additional direction provided by the Commission's *March 16<sup>th</sup> Order* into the 2023 USECP. March 27<sup>th</sup> Petition at 2.

To date, no protests or other responsive pleadings have been filed relative to PGW's March 27<sup>th</sup> Petition. Accordingly, PGW's request for an extension to file its Revised 2023 USECP, consistent with the *January 12<sup>th</sup>* and *March 16<sup>th</sup> Orders*, is granted. PGW is directed to file its Revised 2023 USECP no later than June 12, 2023.
