Application of Verizon Pennsylvania LLC for approval to alter the public crossing (DOT 507 694 K) by installation of an aerial cable where Border Street crosses, at grade, two (2) tracks of Norfolk Southern Railway Company located in West Elizabeth Borough, Allegheny County.

To Whom It May Concern:

By Secretarial Letter dated May 19, 2021, we directed the alteration of the at-grade crossing (DOT 507 694 K) by the installation of an aerial cable where Border Street crosses, at grade, two (2) tracks of Norfolk Southern Railway Company located in West Elizabeth Borough, Allegheny County. All work at the subject crossing was to be completed on or before May 31, 2022.

By petition received on April 3, 2023, Verizon Pennsylvania LLC requests the Commission grant a two (2) year extension of time in which to complete the project. Verizon Pennsylvania LLC avers that the time extension is necessary due to a delay by the construction crew.

We have carefully reviewed the record in this proceeding and will grant Verizon Pennsylvania LLC's petition for an extension of time to April 30, 2025.

THEREFORE:

The petition received April 3, 2023, from Verizon Pennsylvania LLC be and is hereby granted to the extent herein directed:

1. Paragraph 8 of our Secretarial Letter dated May 19, 2021, which reads as follows, to wit:

“8. The alteration of the crossing be completed on or before May 31, 2022, and that on or before said date Verizon Pennsylvania LLC, report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with the approved plan and this Secretarial Letter.”

be and is hereby modified to read:

8. The alteration of the crossing be completed on or before April 30, 2025, and that on or before said date Verizon Pennsylvania LLC, report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with the approved plan and this Secretarial Letter.

2. In all respects not inconsistent herewith, our Secretarial Letter dated May 19, 2021, remains in full force and effect.

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.



If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. There are certain filings that cannot be eFiled, such as filings containing confidential or proprietary material. These must be submitted to the Secretary by overnight delivery, priority, or certified mail to allow tracking of your filing.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
