COMPLAINT

The Pennsylvania Public Utility Commission (Commission) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement hereby represents as follows:

1. That KRISE TRANSPORTATION, INC, Respondent, maintains a principal place of business at 1325 Scotland Avenue Extension, Punxsutawney, Pennsylvania, 15767.


2. On February 14, 2022, Respondent was issued a certificate of public convenience by this Commission authorizing transport, as a common carrier, by motor vehicle, persons in paratransit service, from points in the Counties of Allegheny, Dauphin, Erie, Indiana, Jefferson and Lawrence, to points in Pennsylvania and return at PUC utility code no. 640101. Information contained in that letter "Certificate holder is advised to become familiar with the requirements of 52 Pa. Code. Failure to comply with all applicable requirements may subject the carrier to penalties, including fines suspension of operating rights or cancellation of authority. Title 52 of the Pennsylvania Code may be accessed on the World Wide Web at www.pacode.com."

3. PUC Enforcement Officer Gerald Stover attempted several times to contact Respondent. Due to the carrier's circumstances additional time was extended to the carrier beyond the 180 days required for the Safety Fitness Review. Respondent did provide incomplete information to Officer Stover. Officer Stover emailed and phoned the company Director of Safety and Compliance, Scott A. Labay, for the additional documents. As of December 14, 2022, Respondent has failed to provide the information to Officer Stover to establish a satisfactory safety fitness review.

4. That Respondent, by failing to achieve a satisfactory evaluation on a safety fitness review, violated 66 Pa. §501(c) and, for failure to maintain adequate, efficient, and safe service and facilities, violated 66 Pa. §1501. The penalty for this violation is cancellation of the certificate held by Respondent with this Commission at utility code 640101.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission revoke the certificate of public convenience issued Krise Transportation, Inc, at PUC utility code no. 640101.



An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer shall raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified, and the original shall be mailed to:

The penalty could include a fine, the suspension or revocation of your certificate of public convenience or other remedy.
- C. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty.
- D. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge for hearing and decision. The judge is not bound by the optional fine set forth above.
