In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less.

Subject to Notes AA and 1 to 9 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3, and 4.

Hourly rates apply only from the time of arrival of vehicles and men at the first point of origin (continued during all loading, transportation from the first point of origin to the final destination, and unloading) until completion of unloading and dismissal of vehicles and men by shipper at the destination.

Traveling charges cover traveling to the first point of origin and traveling from the final destination, irrespective of actual time involved in such traveling.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3, and 4).

NOTE 2 - Hourly rates (Columns 2, 3, and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays: 7 hours plus applicable travel charge at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (5:01PM to 7:59AM): 3 hours plus applicable travel charge at rates named in Columns 1 and 4. Weekdays (8:00AM to 5:00PM): 3 hours plus applicable travel charge at rates named in Columns 1 and 3. On shipments of household goods, in use, having a gross cubic measurement of 150 cubic feet or less, the Minimum Transportation Charge is 2 hours plus applicable travel charge at rates named in Column 1 and Columns 2, 3 or 4.

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier.

NOTE 6 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

NOTE 7 - Rates named in Columns 3 and 4 apply from 8 A.M. to 12:00 Midnight on any day when a higher rate is shown for the following day.

NOTE 8 - When an upright piano, baby grand piano, grand piano or safe weighing in excess of 200 pounds are included in the shipment, an additional cost of **\$175.00** per applicable item will apply.

▲ NOTE 9 - In lieu of transportation rates for shipments transported in excess of forty (40) miles in Freight PA. P.U.C. No. 51, the carrier elects to waive Non-Peak Season Rates on Page 58 and will use Peak Season rates on Page 58-B for all moves throughout the entire year.

▲ NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 10 miles	1/2 hour
11 - 25 miles	1 hour
26 - 40 miles	1 1/2 hours
41 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
