Aqua has known since the year 2019 when they acquired the Cheltenham Township waste water lines that deduct water meters exist. They have continued negotiating the purchasing of municipally owned waste water facilities since then and failed to inquire of the sellers that they were acquiring additional customers with deduct water meters. Both the sellers and the buyer are failing their responsibilities to treat EVERYONE fairly. Aqua has had years to propose a fair solution to the problem and now want to grandfather the discriminatory practice of some customers being able to avoid a charge for water not going to a waste water facility. All of the much larger quantity of customers who may or may not have known of the deduct meter system both now or in the future are denied its benefit. This president of not notifying EVERY customer and not allowing every customer now and in the future that if they wish to purchase and install at their expense a meter to avoid paying a waste water company that has a monopoly for a service that that company is not performing is deceitful and fraudulent.

On Page 6 Last sentence "By limiting the eligible customers to these three rate zones that already purchased a deduct meter at their own expense and installed on their own water lines, the company will not incur any additional expenses to install deduct meters on customers owned water lines particularly in areas where Aqua is not the water provider. On page 3 and 4 of Aqua's brief they state and underlined "at their own expense" The last

The Company has not stated that they definitely will notify all customers of a rate zone, a proposed adjustment that would affect the customer. They have not definitely stated that they will propose or adopt a procedure to accept a water usage reading of water not going to waste water treatment if the customer provides that usage at the customers cost.

The recorded evidence in the proceedings of all the documents is clearly unreasonable, very discriminatory, requiring some customers to pay for a service not being provided and must not be approved.

For all of my testimony I've provided I respectfully request that Administrative Law Judge Darlene Heep and The Pennsylvania Public Utilities Commission deny Aqua Supplement No. 2 as it is written and refile it notifying all rate zone customers that it affects with fair language.
