3. Verizon Pennsylvania LLC requests permission to place a fiber optic cable and innerduct in the Borough of West Mifflin, Allegheny County. **Projected Start Date for this project is June 1, 2023.**
4. The proposed construction will involve a placement of an aerial fiber optic cable and innerduct being attached to existing Verizon poles and underneath the bridge (Exhibit A).





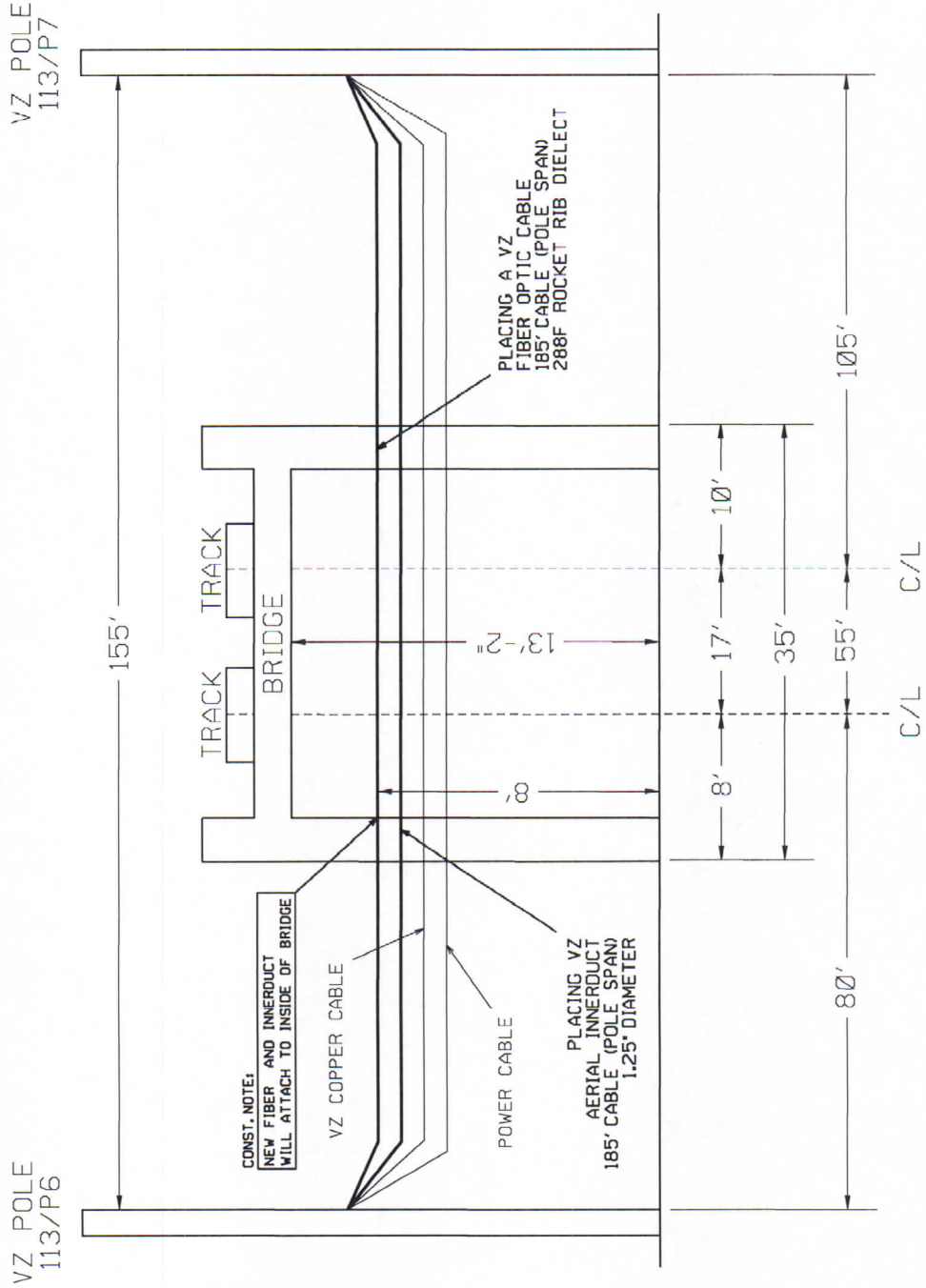
