NOTE 5 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

NOTE 6 - In lieu of the applicable rates provided for in Tristate 50-T and Tristate 51-W, packing and unpacking labor will be performed using the carrier's hourly rates shown above. This applies to all shipments traveling between points in Pennsylvania and transported 40 miles or less and shipments transported in excess of 40 miles.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.
