PHILADELPHIA GAS WORKS' MOTION TO CONTINUE

Pursuant to 52 Pa. Code §1.15, Philadelphia Gas Works (“PGW” or “Respondent”) hereby files this Motion to Continue the evidentiary hearing in this matter, which is scheduled for Monday, May 1, 2023. In support of this Motion, PGW states as follows:

1. By notice dated March 20, 2023, the Commission scheduled a telephonic hearing in this matter for Monday, May 1, 2023 at 10:00 a.m., before Administrative Law Judge Marta Guhl.
2. Pursuant to 52 Pa. Code §5.231(a) and the Prehearing Order issued on April 24, 2023, PGW has contacted the Complainant, Ms. Odd, and is attempting to reach a resolution in this matter.
3. The Complainant has agreed to provide documentation that could aid the parties in reaching a resolution in this matter; however, that documentation is still outstanding.
4. It is unlikely that PGW and the Complainant will be able to reach a resolution to this matter prior to the scheduled court date.
5. PGW and the Complainant have agreed to request a continuance in this matter to allow the parties to obtain and review the documentation and attempt to reach a resolution.

WHEREFORE, PGW requests that the hearing scheduled for Monday, May 1, 2023, in the above captioned matter be continued.
