**PHILADELPHIA GAS WORKS' MOTION TO CONTINUE**

Pursuant to 52 Pa. Code §1.15, Philadelphia Gas Works (“PGW” or “Respondent”) hereby files this Motion to Continue the evidentiary hearing in this matter, which is scheduled for Tuesday May 2, 2023. In support of this Motion, PGW states as follows:

1. By notice dated March 20, 2023, the Commission scheduled a telephonic hearing in this matter for Tuesday May 2, 2023 at 10:00 a.m., before Administrative Law Judge Eranda Vero.
2. Pursuant to 52 Pa. Code §5.231(a) and the Prehearing Order issued on March 20, 2023, PGW has contacted the Complainant, Paulette Hackney, and discussed possible settlement of this matter.
3. The Complainant has indicated that she needs additional time to make the arrangements necessary to effectuate settlement.
4. PGW has agreed to hold the settlement offer open until May 17, 2023.
5. PGW and the Complainant ask that this matter be continued to a date after May 17, 2023 to give the parties an opportunity to reach a resolution.
