Dear Secretary Chiavetta:

Philadelphia Gas Works ("PGW") received complaints filed by Grays Ferry Cogeneration Partnership and Vicinity Energy Philadelphia, Inc. (collectively "Vicinity")¹, the Philadelphia Industrial and Commercial Gas Users Group ("PICGUG")², and James Williford³ in the abovecaptioned matter. It is anticipated that the complaints will be consolidated in PGW's rate proceeding, consistent with Commission practice. Accordingly, with respect to the complaints that have been filed, and any complaints hereafter filed, PGW, in lieu of filing answers thereto, will rely upon 52 Pa. Code § 5.61(d), which provides:

For complaints which are docketed with Commission-instituted rate proceedings, an answer may be filed within 10 days of date of service. However, an answer is not required, except as may be directed by the Commission or the presiding officer.

If the Commission or presiding officer(s) direct that answers should be filed to any complaints, we request that PGW be provided 10 days from the date of such directive to file answers to such complaints.
