HUNKS HAULING JUNK AND MOVING

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less.

Subject to Notes AA and 1 to 3 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3 and 4.

NOTE 2 - When pianos are part of a move, the following flat charges will apply in addition to the hourly rates shown above:

NOTE 3 - When shipment needs to be held overnight for the convenience of the customer, an overnight holding fee of \$250.00 per truck per night will apply in addition to all other applicable charges.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3 and 4 will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.
