**SURRENDER OF CERTIFICATE OF PUBIC CONVENIENCE
FROM THE TRUSTEES OF CONNEAUT LAKE PARK, INC.**

AND NOW comes Conneaut Lake Park Inc. Trustees ("Trustees"), by and through its attorneys, MacDonald, Illig, Jones & Britton, LLP, and submits this Surrender of Certificate of Public Convenience from the Trustees of Conneaut Lake Park, Inc. and states as follows:

1. On April 20, 2023, the Pennsylvania Public Utility Commission ("PaPUC") issued an Order approving the request of the Trustees to abandon water service to the public in portions of Summit and Sadsbury Townships, Crawford County, Pennsylvania.

2. The PaPUC also ordered that "upon issuance of the Certificate of Public Convenience pursuant to Ordering Paragraph 5, the Trustees of Conneaut Lake Park, Inc. shall return all copies of previously issued Certificates of Public Convenience to the Commission's Secretary's Bureau."

3. The PaPUC has issued the Certificate of Public Convenience to Conneaut Lake Park Water Corporation, Inc., triggering the Trustee's obligation to return its Certificate of Public Convenience.

4. The Trustees have engaged in an exhaustive search to find the original sealed Certificate of Public Convenience issued to the Trustees, but has been unable to locate it.

5. The Trustees have located a copy of such Certificate of Public Convenience, attached as Exhibit A, and is submitting this as evidence of its intent to abandon the water service that it provided to the public in portions of Summit and Sadsbury Townships, Crawford County, Pennsylvania as approved by the PaPUC.

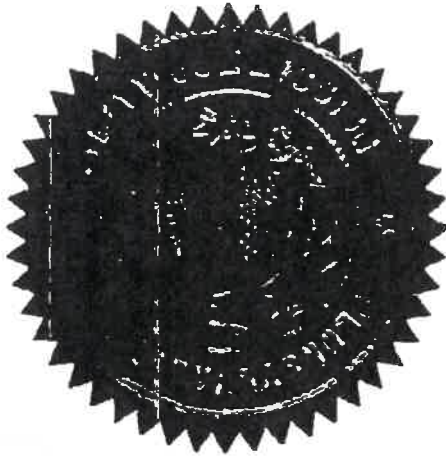
