

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 5 hours plus applicable travel charge at rates shown for day of the week services are performed. Monday - Saturday (any hour): 4 hours plus applicable travel charge at rates shown for day of the week services are performed during Peak Season and 3 hours plus applicable travel charge at rates shown for day of the week services are performed during Non-Peak Season.

NOTE 5 - Waiver of minimum charges - carrier convenience: Carrier shall not assess a minimum charge (number of hours) whenever a move is less than the minimum number of hours filed and said move is performed solely at carrier's convenience. In such instances, the carrier shall charge based on the actual time to complete the move plus applicable travel charge.

NOTE 6 - Regular work hours are 7:00AM to 7:00PM. Any moves performed Monday - Thursday outside those hours will be subject to the Friday & Saturday rates.

NOTE 7 - Additional charges will apply when bulky items, major appliances and exercise equipment are included in the shipment as follows:

NOTE 11 - A prepaid deposit of \$250.00 is required for moves utilizing 2 or 3 movers and \$500.00 for moves utilizing 4 plus movers.

Cancellation Policy: The prepaid deposit is not refundable if move is cancelled 3 days or less prior to the scheduled move date. Carrier reserves the option to waive the prepaid deposit or cancellation fee based on circumstances.
