

On March 17, 2023, Aqua submitted a letter requesting that the Pennsylvania Public Utility Commission (“Commission”) extend its initial review period of the above-captioned Application from March 21, 2023, to April 7, 2023. The Commission granted Aqua’s request by Secretarial Letter dated March 20, 2023. On April 5, 2023, Aqua submitted a request for a further extension of the initial review period of the Application from April 7, 2023, to April 21, 2023. The Commission granted Aqua’s request for a further extension by Secretarial Letter dated April 6, 2023. On April 19, 2023, Aqua submitted a request for a further extension from April 21, 2023, to May 5, 2023. The Commission granted Aqua’s request for a further extension by Secretarial Letter dated April 20, 2023.

Aqua is continuing to prepare its responses to the Commission’s requests for additional information. Based upon the current status of its review, Aqua believes that additional time is needed to prepare responses and gather documents responsive to the Commission’s requests for additional information. Therefore, Aqua asks that this letter be accepted as Aqua’s request to further extend the Commission’s initial review period from May 5, 2023, to May 19, 2023.


