**NOTE 1** - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays (any hour): 8 hours at rates in Columns 1 and 2. Saturdays (any hour) and Weekdays (5:01 PM to 6:59 AM): 4 hours at rates named in Columns 1 and 4 plus applicable travel charge. Weekdays (7:00AM to 5:00PM): 4 hours at rates named in Columns 1 and 3.

**NOTE 2** - BULKY ITEMS. \$125.00 surcharge for pianos, safes, exercise equipment, machinery, appliances, etc. weighing in excess of 200 pounds. For service other than street level floor: additional surcharge of \$25.00 per floor.

**NOTE 3** - LAYOVER/STORAGE-IN-TRANSIT: Holding items on truck at shipper's request as agreed upon with shipper and carrier. If items cannot be delivered within the agreed upon time period, then shipment will be moved to storage at all prevailing rates. Cost for overnight holding is \$200.00 per night per vehicle plus applicable travel time and hourly rates (named in columns 1, 2, 3, and 4) on delivery date.

**NOTE 4** - In lieu of the applicable packing and unpacking rates shown in Tariff Freight Pa. P.U.C. No. 50, carrier will assess hourly rates as named in Columns 1, 2, 3, and 4.

**NOTE AA** - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.
