


STATUS REPORT

As indicated in the Status Report filed February 10, 2023, Blackwood, Inc. served its proposed Certificate of Readiness/Praecipe for Certification to list for non-jury trial the Schuylkill County litigation involving the parties captioned to S-1179-2008, pending position of the counsel for the Railroad and the Township on the need for further discovery.

Since that time, counsel for the Railroad has indicated the desire to take depositions in the case as final trial preparation.

Counsel for Blackwood and the Railroad are working now to have those depositions scheduled and move the case to trial in Schuylkill County, in order that the Schuylkill County case may be resolved as the predicate to proceeding with the cases pending before the Commission.
