Application of the Pennsylvania Department of Transportation for approval to alter the public crossing (DOT 592 187 F) by replacement of the existing bridge where SR 3007 (19<sup>th</sup> Street) crosses, above grade, the tracks of Norfolk Southern Railway Company, located in the City of Harrisburg, Dauphin County and for an exemption from the Commission's minimum overhead (vertical) clearance requirements as set forth in Title 52 Pa Code §§33.121; and the allocation of certain costs and expenses incident thereto.

To Whom It May Concern:

In accordance with Numbered Paragraph 4 of the Commission's Secretarial Letter dated February 23, 2021, in the above-captioned proceeding, the Pennsylvania Department of Transportation (Department) has submitted final construction plans and bridge structural plans for this Commission's approval.

The Pennsylvania Department of Transportation avers that the respective parties have been served with a copy of the plans for review on March 30, 2023, and none of the parties have filed an objection to the approval of the plans with this Commission.

The plans were received by the Commission on March 30, 2023, and are hereby entitled "COMMONWEALTH OF PENNSYLVANIA DEPARTMENT OF TRANSPORTATION DRAWINGS FOR CONSTRUCTION OF STATE ROUTE 3007 SECTION 020 IN DAUPHIN COUNTY" consisting of one hundred ninety-nine (199) sheets.

The Department has resubmitted a signed title sheet for the subject plans at the request of the Commission which will replace the original unsigned title sheet submitted on March 30, 2023. As per the Department, no plan sheets have changed other than the signature block on the title sheet.

Please be advised that the above stated set of plans have been certified as the correct plans and are hereby approved.

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.



All filings should be addressed to the Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120. The Commission will not accept documents delivered by fax or by e-mail. Parties are encouraged to file formal documents by eFiling with the Secretary of the Commission by opening an eFiling account through the Commission's website (the account is free of charge) and accepting eService at <https://www.puc.pa.gov/filing-resources/efiling/>.

If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. There are certain filings that cannot be eFiled, such as filings containing confidential or proprietary material. These must be submitted to the Secretary by overnight delivery, priority or certified mail to allow tracking of your filing.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
