On behalf of Stream Energy Pennsylvania, LLC ("Stream Energy"), please accept this Annual Compliance Filing to renew its required level of financial security at the reduced level of 5% of its most recent 4 quarters of revenue. This renewal request is being submitted at least 90 days prior to the anniversary date of Stream Energy's current security.

Stream Energy's initial reduction in financial security was granted by the Commission through a Secretarial Letter dated August 4, 2016. Stream Energy's security reduction has been renewed annually. Stream Energy files this Annual Compliance Filing to renew its security at the reduced level of 5% based on its recent 4 quarters of revenue.


