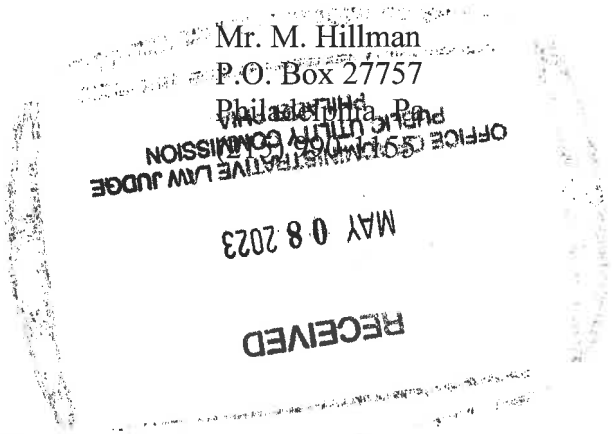

ARGUMENT

At this point, if the PUC has a problem with me representing myself, then this court is not the proper forum for me. Furthermore, my intent to show-up in court, is to prove my case and there is no way for me to be successful, being restricted to merely answer questions from the court and (or) the defendants/respondents. From my position, sitting back to answer yes or no to questions, is not proving anything, at all.

For instance, during the PECO hearing on 4/27/23, I requested to make a very, short statement of facts for 5 minutes or less (which would save lots of time & tax dollars) but I was prevented from doing so. Rule 131 of Philadelphia County provides me the right, as a Pro Se Litigant.

Therefore, I am inquiring information regarding the Pa. Rule or Statute that strips me of Pro Se Litigants Rights or would this be part of PUC Rules (Please send them to me). By limiting me to the words yes or no, I am accused of talking over everyone, if I speak beyond those two words. The same scenario has occurred during the prior PUC hearing. So, I would like to know, which rule or statute applies here, when denying me the right to make a very, short statement of facts, then limit me to answer questions.

Moreover, the inhumane treatment we experienced at our residence, by the utilities being shut-off for approximately 20 months, I do not agree to show-up at a hearing to be muffled, and simply answer questions, as if I am the criminal, here. In fact, by being the Plaintiff/Complainant in this case, I have no intentions of participating in the hearing for the purpose of just answering questions (in-person or by telephone). Having said that, there is an Aqua hearing scheduled in two weeks and rescheduling of the Peco hearing. Hopefully, someone will make the necessary arrangements in order to save time & tax dollars.



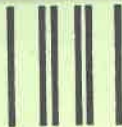
