TRAVEL FREE LLC HAS NOT OPERATED NOR DID EVER OPERATE AS A MOTOR VEHICLE PARATRANSIT SERVICE. MR. JASON ALEXANDRE HAS NEVER RECEIVED ABANDONMENT FORM. PLEASE PROVIDE EMAIL ADDRESS PUC ENFORCEMENT OFFICER REYNALDO PERLUISSE CLAIMS TO HAVE UTILIZED TO EMAIL ABANDONMENT FORM. THOUGH COMPLAINT IS NULL AND VOID, TRAVEL FREE LLC NO LONGER INTENDS TO OPERATE AS A MOTOR VEHICLE PARATRANSIT SERVICE PROVIDER. REVOCATION OF PUC CERTIFICATE IS GRANTED. 

COMPLAINT

The Pennsylvania Public Utility Commission (Commission) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement hereby represents as follows:

1. That TRAVEL FREE, LLC, Respondent, maintains a principal place of business at 18 Red Tail Court, Limerick, Pennsylvania, 19468

2. On May 18, 2022, Respondent was issued a certificate of public convenience by this Commission authorizing transport, as a common carrier, by motor vehicle, persons in paratransit service, from points in the County of Philadelphia to points in the county of Philadelphia at PUC utility code no. 6424728. Information contained in that letter "Certificate holder is advised to become familiar with the requirements of 52 Pa. Code. Failure to comply with all applicable requirements may subject the carrier to penalties, including fines suspension of operating rights or cancellation of authority. Title 52 of the Pennsylvania Code may be accessed on the World Wide Web at www.pacode.com."

3. Between December 28, 2022, through January 11, 2023, PUC Enforcement Officer Reynaldo Perluisse attempted several times to contact Respondent by phone. On January 18, 2023, Officer Pierluisse, spoke with Jason Alexandre regarding the SFR to which Mr. Alexandre stated that the carrier has not operated at which time Officer Pierluisse advised Mr. Alexandre that an abandonment form must be completed as required by law. Officer Pierluisse also emailed all the information. Respondent has not contacted the regional office nor filed the abandonment form.

4. That Respondent, by failing to file an application with this Commission prior to abandoning or discontinuing service, violated 52 Pa. Code §3.3819(a) and 66 Pa. C.S. §1102(a)(2). The penalty for this violation is cancellation of the certificate held by Respondent with this Commission at utility code 6424728.
