Dear Secretary Chiavetta:

We are counsel for Aqua Pennsylvania Wastewater, Inc. (“Aqua”) in the above-captioned matter. On March 17, 2023, Aqua submitted a letter requesting that the Pennsylvania Public Utility Commission (“Commission”) extend its initial review period of the above-captioned Application from March 21, 2023, to April 7, 2023. Aqua has subsequently sought, and the Commission has granted, additional requests for an extension of the initial review period of the above-captioned Application. Most recently, on May 3, 2023, Aqua requested an extension of the review period from May 5, 2023 to May 19, 2023. The Commission granted this requested on May 5, 2023.

On May 18, 2023, Aqua submitted additional information in response to the Commission’s Bureau of Technical Utility Services’ (“TUS”) requests for additional information. With this submission, Aqua has responded to all of TUS’ requests for additional information except for Request No. 7. Aqua is continuing to prepare its response to this request. Based upon the current status of its review, Aqua believes that additional time is needed to prepare this response and gather responsive documents. Therefore, Aqua asks that this letter be accepted as Aqua’s request to further extend the Commission’s initial review period from May 19, 2023, to June 2, 2023.
