Request for Information

- a) For question #10 of the application, it asks you to describe the proposed service area. You stated that you wish to provide paratransit service between points in Pennsylvania.
 - a. For example, if someone in Erie County calls and wishes to use your service, you cannot by regulation deny them service. Is it your intention to offer service from counties so far away from your base of operation? And if so, how do you intend to adequately service such a large area of operation. If it is not your intention to operate between points in Pennsylvania, then please respond with the area(s) that you wish to originate and terminate service.
- b) Question #5b of the Verified Statement of Applicant asks for your system for conducting criminal background checks. You stated that your procedure consists of numerous criminal and immigration and license checks but does not offer any details as to what these checks are, or with whom they are made by. Please give your system for conducting criminal background checks.
- c) Question #5c of the Verified Statement of Applicant asks for your driver training program. You failed to indicate what this program is. Please provide your driver training program.
- d) Question #5d of the Verified Statement of Applicant asks for your system for conducting license checks. You mention that license checks will be done, but you fail to identify the system for conducting license checks. Please provide said system.
- e) Question #5e of the Verified Statement of Applicant asks for your policies regarding alcohol and drug use by your drivers, but you failed to indicate said policies. Please provide your policies regarding alcohol and drug use by your drivers.
