ANSWER TO NEW MATTER

AND NOW, comes Complainant, Andrew Cappella, and files the within Answer to the New Matter filed by Respondent, West Penn Power:

12. Accepted in part, denied in part. Although the 2022 Commission PAR defaulted due to non-payment due to not making payments as directed to by the BCS decision dated June 23, 2022, there was a payment of \$250.00 received by the Respondent on August 16, 2022, as can be seen in the Respondent's Attachment 1 in Answer and New Matter. In addition, a LIHEAP grant was applied on April 4, 2022, provided as Attachment 1.
13. Denied. When the BCS Decision No. 3895096 was issued on April 26, 2023, there was a substantial decrease in income. As shown in Attachment 2, the Complainant did have employment with Giant Eagle in 2022 and had an income of \$9,075.91 over the course of employment. However, as shown in Attachment 3, the Complainant was still employed by Giant Eagle, but had zero income. Therefore, since income was earned in 2022 but not 2023, it can be determined there was a significant change in income and circumstances, thus making the

Complainant entitled to a subsequent Commission PAR or an extension. To the extent that it is maintained the Complainant did not have a change of income, strict proof is demanded at trial.

14. Accepted in part, denied in part. There is no dispute that the Respondent has the right to bill and receive payment for the utility services that are actually supplied. However, the consumer also has the right to receive an accurate bill free of errors. *PA Energy Consumer Bill of Rights, page 2, Filing Complaints*. In the BCS Decision No. 3841025, it was stated the terms were budget + \$66.00. However, the Late Payment Charges were to be waived as well. There were LPC in October 2021, November 2021, December 2021, January 2022, February 2022, March 2022, January 2023, February 2023, and March 2023. If the Complainant is indeed guaranteed the right to receive an accurate bill, those Late Payment Charges must be removed as directed by the BCS Decision No. 3841025.

WHEREFORE, in light of the foregoing, Complainant, Andrew Cappella, respectfully requests that his Complaint and the remedies requested therein be granted, that he be granted such additional and further relief as the Commission deems just and proper, and that the Respondent's request for dismissal be denied.
