

NOTE 1 - MINIMUM TRANSPORTATION CHARGES:

Saturday, Sundays and Holidays (any hour): Two (2) hours plus applicable travel charge at rates named in Columns 1 and 2.

Weekdays - Monday-Friday (any hour): Two (2) hours plus applicable travel charge at rates named in Columns 1 and 3.

NOTE 2 - In lieu of accessorial rates published in Freight Pa. P.U.C. Nos. 50 & 51 (Tristate 50-T & 51-W) for shipments traveling between points in Pennsylvania and transported forty (40) miles or less and in excess of forty (40) miles, schedules applicable for York County will apply. This includes containers and packing/unpacking labor. Charges for Item 160 (Additional Transportation Charge) on Page 45 of Tristate 51-W is excluded.

▲ **NOTE AA -** Travel charge to be based on the applicable transportation rates shown in Columns 2, and 3 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 20 miles	1 hour
21 - 40 miles	1 1/2 hours
41 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.
