FirstEnergy's Joint Proposed 2024-2028 USECP

**RE: CAUSE-PA May 31, 2023 Request for Extension of Filing Deadlines for the
FirstEnergy Joint Proposed 2024-2028 USECP**

On April 25, 2023, Metropolitan Edison Company, Pennsylvania Electric Company, Pennsylvania Power Company, and West Penn Power Company (collectively, FirstEnergy) jointly filed supplemental information at the captioned dockets in response to the Pennsylvania Public Utility Commission's (Commission's) March 16, 2023 Order which addressed FirstEnergy's Joint Proposed 2024-2028 USECP. Thereafter, on May 31, 2023, FirstEnergy filed an amendment to its supplemental information (FirstEnergy Amended Response) due to a formula error used to calculate projected average monthly utility bills for 2024 through 2028. FirstEnergy Amended Response at 1.

On May 31, 2023, CAUSE-PA filed a Petition (CAUSE-PA Petition) in response to FirstEnergy's Amended Response seeking an extension for the comment and reply comment periods as follows:

- Extend the comment period from June 5, 2023, to June 20, 2023.
- Extend the reply comment period from June 26, 2023, to July 10, 2023.


CAUSE-PA Petition at 1.

CAUSE-PA has indicated that an extension for these filing deadlines "would provide a reasonable period of time for the parties to analyze the revised data and amend their comments and recommendations accordingly without undue delay." CAUSE-PA asserts that it consulted with the other parties in this proceeding about these proposed extensions and that they have no objection. CAUSE-PA Petition at 1.

Based on the request and explanation provided and the absence of stakeholder objection, we find it reasonable to grant CAUSE-PA's Petition to amend the filing deadlines for comments and reply comments in this proceeding.

Accordingly, comments for all stakeholders in FirstEnergy's 2024-2028 USECP proceeding are due on or before Tuesday, June 20, 2023, and reply comments are due on or before Monday, July 10, 2023. Questions may be directed to Jennifer Johnson at jennifjohn@pa.gov.
