I am writing to confirm that on May 5, 2023, L5E, LLC, a Texas limited liability company and a licensed Electric Broker (A-2012-2334259) and a licensed Natural Gas Broker (A-2014-2422500) in the State of Pennsylvania acquired 100% of the outstanding shares of BidURenergy, Inc., a New York corporation, and a licensed Electric Broker (A-2009-2149584) and a licensed Natural Gas Broker (A-2014-2435424) in Pennsylvania. Prior to this acquisition, BidURenergy, Inc. was owned by NRG Energy, Inc. Effective May 5, 2023, BidURenergy, Inc. became a wholly-owned subsidiary of L5E, LLC.
