Please find attached a **RATE CHANGE** for Freight Pa. P.U.C. No. 2, effective July 17th, 2023 (this tariff cancels Freight Pa. P.U.C. No. 1), for Broad Street Movers, LLC (PA PUC Certificate ~~#A-6946267~~), 1201 North 3rd Street, Box 284, Philadelphia PA 19122.

Changes are for **INCREASES** in the piano handling fee, rates for additional labor & trucks, flight charges, container rates, and local hourly charges and a **CHANGE** in the minimum transportation charge. All changes are shown on Page 3, 4 and 5 of this tariff, Freight Pa. P.U.C. No. 2.

SECTION 1
RULES & REGULATIONS

ITEM 10 - GOVERNING PUBLICATIONS

For rates, rules, regulations and provisions applicable to the transportation of household goods, in use, except as otherwise specifically provided herein, see Tariff Freight Pa. P.U.C. No. 53 (Carrier Directory No. 53), loose-leaf revisions thereto and successive issues thereof, issued by Tristate Household Goods Tariff Conference, Inc., Agent.

ITEM 20 - CLASSIFICATION OF PROPERTY

Class 1 shipments are personal effects and property used or to be used in a dwelling when a part of the equipment or supply of such dwelling and such other similar property; except that this subparagraph shall not be construed to include property moving from a factory or store, except such property as the householder has purchased with the intent to use in his dwelling and which is transported at the request of, and the transportation charges paid to the carrier by the householder.

ITEM 30 - DECLARED VALUE

Rates and charges named herein applicable when the value declared by shipper does not exceed sixty (60) cents per pound per article. For the method of determining rates when declared value exceeds sixty (60) cents per pound per article, see Governing Tariff.

ITEM 40 - ADDITIONAL EXPENSES

Any tolls, parking fees or parking tickets incurred at the client's origin or destination will be the responsibility of the client and added to the carrier's charges and billed to the customer. Please be aware, tolls for commercial vehicles are often more expensive than tolls for passenger vehicles.

SECTION 2

ADDITIONAL SERVICE CHARGES

ITEM 200 - PIANO FEE

◆ When a piano is included in the shipment, an additional handling fee of \$200.00 will be assessed. Please Note: The carrier only moves spinet, console and upright pianos and only moves them from first (1st) floor at one location to a first (1st) floor at another location. The carrier does not relocate player, baby grand or grand pianos and does not take pianos up or down flights.

ITEM 210 - LONG CARRY FEE

If movers need to carry the contents of a shipment over a distance greater than 100 feet, a long carry charge will apply as follows:

Over 100 feet to 125 feet - \$100.00 126 feet to 150 feet - \$125.00 151 to 175 feet - \$150.00 176 feet to 200 feet - \$200.00

A corresponding charge of \$25.00 will be assessed for each additional 25 feet long carry. A separate long carry fee will be assessed at each location.

ITEM 220 - ADDITIONAL LABOR AND ADDITIONAL TRUCKS

◆ When additional labor is requested or required, the additional cost will be \$50.00 per laborer. When the property being moved is deemed too large to fit on one truck, carrier may use a second vehicle. The additional cost is \$250.00 per each additional truck.

ITEM 230 - OVERNIGHT HOLDING FEE

In the event a customer needs their shipment held overnight, an additional fee of \$250.00 will be charged per truck per night. In addition, the hourly rate will begin to accrue at 9:00AM on the next business day or the earliest time the carrier is available to continue the move. The hourly rate will continue to accrue until the job is completed. Customer will be responsible for any additional travel time or other expenses incurred as a result of holding the customer's shipment overnight.

ITEM 240 - TRAVEL CHARGE

A travel time fee based on the time it takes for the moving crew to travel from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal will be assessed using the hourly rates in Section 4, Item 400, of this tariff. The travel time fee is subject to a one (1) hour minimum charge.

ITEM 250 - FLIGHTS OF STAIRS

◆ Rates will increase based on the number of flights of stairs that movers must ascend above a third (3rd) floor at all locations of the move. Consider the ground floor or first floor to be interchangeable terms for the same floor. Flights of stairs outside a house or apartment will be factored into the total number of flights of stairs. Flights of stairs within an apartment will be factored into the total number of flights of stairs. Flights of stairs leading up to attics, roof decks or crawl spaces in the ceiling will also be factored into the total number of flights on a job. Any floor above the third (3rd) floor will have an additional flat charge of \$25.00 per mover per each additional flight at each location (i.e. A three men crew with four (4) flights at origin or destination will be an additional charge of \$75.00 and a three men crew with four (4) flights at origin and another four (4) flights at destination will be an additional charge of \$150.00). Every effort will be made to determine the number of flights of stairs prior to the start of the move; however, if the total number of flights is different than the carrier's understanding when the estimate was submitted, the carrier reserves the right to add the additional flat charge based on the actual number of flights of stairs involved in the move.

SECTION 3
ADDITIONAL SERVICE CHARGES

ITEM 300 - CONTAINER AND PACKING & UNPACKING LABOR CHARGES

The container charges shown below will be assessed when the carrier supplies containers for packing the contents of a customer's residence. The hourly labor rates in Section 4, Item 400, of this tariff will apply when packing and/or unpacking labor are provided by the carrier. In addition, charges for travel time, fuel surcharge, tolls, etc. will apply if applicable. All packing and/or unpacking labor is subject to a two (2) hours minimum charge. Rates shown apply to shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less and distances in excess of forty (40) miles.

SECTION 4
HOURLY RATES

ITEM 400

Applicable on the transportation of HOUSEHOLD GOODS IN USE traveling between points in Pennsylvania and transported distances of forty (40) miles or less.

The transportation charge on any shipment shall be a combination of the applicable traveling charge (Item 240) plus hourly charges shown below at applicable rates in Columns 2, 3 and 4.

NOTE 1 - Traveling charges (Item 240) are in addition to the hourly rates shown in Columns 2, 3 and 4.

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days, or period of days as indicated, during which services are performed.




NOTE 3 - Hourly rates (Columns 2, 3 and 4) computed in quarter-hour (15 minutes) periods - fractions of one quarter-hour (15 minutes) considered as one-quarter hour (15 minutes).

NOTE 4 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall apply.

▲ NOTE 5 - MINIMUM TRANSPORTATION CHARGES - Moves are subject to a three (3) hours minimum on Saturdays, Sundays and Holidays and a two (2) hours minimum Mondays through Fridays.
