Dear Secretary Chiavetta:

On May 4, 2023, Rhythm Retail, LLC filed its Application to provide service as an Electric Generation Supplier throughout the Commonwealth. Subsequently, your office transmitted a letter requesting a corrected Letter of Credit and an original signature page for the Application. A copy of that letter is attached.


With respect to the Letter of Credit, it appears that the Letter of Credit may have been returned due to the reference to the "Applicant" as being Engie Holdings Inc. o/b/o Rhythm Retail, LLC, whereas the Applicant on the Application is simply "Rhythm Retail, LLC".

For clarification, "o/b/o Rhythm Retail, LLC", means "ON BEHALF OF" Rhythm Retail, LLC. Therefore, Applicant is hereby resubmitting the Letter of Credit and would respectfully request that Letter of Credit be accepted based on the guidance provided by Mr. Jakab.

Also enclosed herewith is the original signature page for the Application. Kindly replace the signature page that was included with the originally filed Application with this corrected signature page. The remainder of the Application remains unchanged. 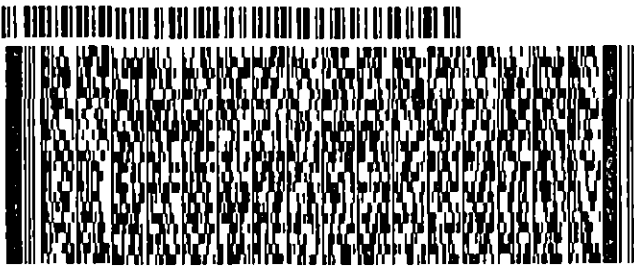
