Dear Ms. Roth,

Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective July 24th, 2023, for SSMT PHL, LLC, t/a Suburban Solutions (PA PUC Certificate #A-8917752) in Havertown PA.

The attached pages are 583rd Revised Page 2, 198th Revised Page 2-B, 83rd Revised Page 2-C, 96th Revised Page 7, 1st Revised Page 94-F, and Original Page 94-F-1.

This filing is requesting a **RATE INCREASE** for local hourly rates, an **INCREASE** in the charge for each additional helper, a **CHANGE** in the application of the travel charge, an **INCREASE** in the cost of containers, a **CHANGE** for the container and packing/unpacking labor rates to apply to shipments transported forty (40) miles or less and shipments transported in excess of forty (40) miles, and a **CHANGE** showing that local hourly rates on Page 94-F will be used for packing/unpacking labor.

PLEASE REMOVE ORIGINAL PAGE 94-G, ORIGINAL PAGE 60-E AND ORIGINAL PAGE 60-F FROM TRISTATE 54 AS THESE PAGES ARE NO LONGER APPLICABLE.

The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are compliant.

The Issue Date for these changes in Tristate 54 is June 23rd, 2023, with an Effective Date of July 24th, 2023.

NOTE 2 - When a piano is part of a move, a flat charge of \$150.00 will be assessed in addition to the hourly rates shown above.

NOTE 3 - Carrier will assess an additional charge of \$10.00 per hour, or fraction thereof, for each flight above three flights. Each location of the move will be assessed separately.

NOTE 4 - Where storage-in-transit is not unloaded at the carrier's warehouse and shipment remains on the carrier's vehicle overnight, an additional S.I.T. flat charge of \$98.00 per vehicle per night will be assessed.
