PHILADELPHIA GAS WORKS’ MOTION TO CONTINUE

Pursuant to 52 Pa. Code §1.15, Philadelphia Gas Works (“PGW” or “Respondent”) hereby files this Motion to Continue the evidentiary hearing in this matter, which is scheduled for Wednesday, June 28, 2023. In support of this Motion, PGW states as follows:

1. By notice dated May 9, 2023, the Commission scheduled an Initial Telephonic Hearing in this matter for Wednesday, June 28, 2023 at 10:00 a.m., before Deputy Chief Administrative Law Judge Christopher Pell.
2. A PGW witness, Mr. Kevin Knecht, is unavailable appear on the scheduled day of the hearing.
3. Mr. Knecht is the PGW employee who inspected the property in question and is a necessary witness.
4. Pursuant to the Prehearing Order issued on May 10, 2023, PGW has reached out to the Complainant and has spoken with Quana Furbert, the Complainant’s brother; Mr. Furbert is an authorized person on the Complainant’s PGW account and a co-signatory on the instant Complaint.
5. PGW has discussed its request for a new court date and its reason for the request with Mr. Furbert who has stated that he and his brother have no objection to PGW’s request.
