Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective July 27th, 2023, for BR Moving, LLC (PA PUC Certificate #A-8916888) in Philadelphia PA.

The attached pages are 584th Revised Page 2, 199th Revised Page 2-B, 101st Revised Page 5, 1st Revised Page 20-G, and Original Page 20-G-1.

This filing is requesting a **CHANGE** in the scope of operating authority to between points in Pennsylvania as this carrier was “grandfathered” for statewide operating authority in May 2015, a **RATE INCREASE** for local hourly rates, an **INCREASE** in the handling charge for a piano when included in the shipment, a **CHANGE** in the application of the travel charge, a **CHANGE** for the container and packing/unpacking labor rates to apply to shipments transported forty (40) miles or less and shipments transported in excess of forty (40) miles, an **INCREASE** in the cost of containers, and an **INCREASE** in the charge for packing/unpacking labor when requested or required.

PLEASE REMOVE ORIGINAL PAGE 20-H AND ORIGINAL PAGE 60-G FROM TRISTATE 54 AS THESE PAGES ARE NO LONGER APPLICABLE.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are compliant.
