Electric Generation Supplier License Cancellations of
Companies with an Expired Financial Security

M-2023-3037455

FINAL ORDER

On April 20, 2023, a Tentative Order was entered in the above captioned proceeding.

The Commission's regulations at 52 Pa. Code §54.42(a) require that a licensee shall comply with the applicable requirements of the code and Commission regulations and orders. Consistent with due process, a license may be suspended or revoked, and fines may be imposed against the licensee for failure to furnish and maintain a bond or other security approved by the Commission in the amount directed by the Commission.

The Electric Generation Supplier (EGS) listed in Table 1 below filed an approved financial security within 30 days after publication in the *Pennsylvania Bulletin*.

Below is the EGS licensee that provided the required approved financial security and is currently in compliance with 52 Pa. Code §54.42(a).



The Electric Generation Supplier Licenses held by the companies listed in Table 2 are cancelled, and shall be stricken from all active utility lists maintained by the Commission’s Bureau of Technical Utility Services, Secretary’s Bureau, and the Assessment Section of the Bureau of Administration, shall be removed from the Commission’s website, and notifications will be sent to all electric distribution companies in which the Electric Generation Suppliers are licensed to do business and the Pennsylvania Department of Revenue – Bureau of Compliance, Business License Clearance Division.

On January 11, 2023, a formal complaint was filed against Integrity Communications of Ohio LLC¹, at Docket No. C-2023-3037584. A decision regarding Integrity Communications of Ohio LLC’s EGS license is not addressed in this Order and will be addressed in a subsequent Order, upon the final resolution of the pending formal complaint.
