This filing is a request for a **RATE INCREASE** for local hourly rates.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are compliant.

NOTE 2 - Rates in Column 4 apply only from 5:01PM to 12:00Midnight on any day when a higher rate is shown for the following day.

NOTE AA - A flat charge based on one-half hour at the applicable transportation rates shown in Columns 2, 3, and 4 is applicable when distance from original point of origin to final destination is 10 miles or less.

NOTE CC - A flat charge based on one and one-half hours at the applicable transportation rates shown in Columns 2, 3, and 4 is applicable when distance from original point of origin to final destination is more than 25 miles (to 40 miles inclusive).
