Data Requests

1. Reference Application, Section 1.a, Identity of Applicant – The Applicant stated throughout its EGS Application Package that the name of the Applicant is Good Energy L.P. The PA Department of State stated that the Applicant’s registered name is Good Energy Limited Partnership. Due to this inaccuracy, please provide a letter that states that the Applicant’s name in the EGS Application Package contains numerous typographical errors and the correct name of the Applicant is Good Energy Limited Partnership.
2. Reference Application, Section 7.a, Financial Fitness –The Applicant’s name on the provided financial security is incorrect. The name must match the Pennsylvania Department of States’s registered name, exactly. Please provide an updated financial security that states the applicants name as Good Energy Limited Partnership.
3. Reference Application, Section 7.b, Financial Fitness – Applicant provided minimal documentation to demonstrate financial fitness. Please provide additional financial fitness documentation that includes three recent consecutive months of bank statements.
4. Reference Application, Section 8.d, Technical Fitness – Applicant misunderstood the Explanation of Ethical Procedures question. The question asks for an explanation of **Ethical** Procedures, not **Ethnic** Procedures. Please provide an updated application page with the appropriate corrections.
