

NOTE 5 - Carrier will supply and charge for a supervisor(s) as requested by shipper. The hourly rate for each supervisor will be computed from the time of arrival of vehicle(s) and men at the first point of origin until the completion of unloading and the dismissal of vehicle(s) and men at the final destination unless another time of arrival and dismissal of the supervisor(s) has been agreed upon by the shipper and the carrier.

NOTE 6 - Rates in Column 4 will apply from 6:01PM to 12:00 Midnight on any day that a higher rate is shown for the following day.

NOTE AA - The traveling charge is based on the actual time required to travel from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal. The hourly rate used for the travel charge is based on the day or days when services are provided using the rates shown above in Columns 2, 3 or 4.

The following applies in lieu of rates published in tariffs, Tristate 50-T and Tristate 51-W for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less and distances in excess of forty (40) miles:

▲ Rates shown for Lackawanna County will be used for all accessorial services (i.e. packing/unpacking labor, additional labor, appliance servicing/unservicing, extra pickup/deliver, overtime loading/unloading, and additional charges for elevators, stairs/flights, and excessive distances/long carries) for all counties within Pennsylvania. The Additional Transportation Charge (Item 160) for Lackawanna County will be applicable at both the origin and the destination for all counties within Pennsylvania unless both origin and destination are in the same county. In that situation, the Additional Transportation Charge will apply at origin only.
