Changes are for an **INCREASE** in local hourly rates, an **INCREASE** in overnight holding after the first night, and an **INCREASE** in charges for containers.


PUC website was checked and Insurance Forms E & H appear to be current and in compliance.

To Whom It May Concern,

I am submitting a Rate Change on behalf of BLL Charles, Inc. dba College Hunks Hauling Junk and Moving (PA PUC Certificate #A-8919262) in Glenshaw PA due to hardship. A message received from Laura Charles, President and Owner, justifying this rate increase is below:

Because I did not anticipate the dramatic change in moving demand as it was unusually low through early June (business has been down an average of 25% since last year due to the increase in mortgage rates). Now that inflation is easing and lending companies are getting creative with mortgage rates, demand is picking up again. Other moving companies also reacting to the demand are poaching my employees offering significantly higher pay and I have to increase wages significantly in order to replace them and keep the ones I have. With the economy and housing market as it is, we need to have more flexibility. If I can't raise rates, I will go out of business.

SECTION 1
RULES & REGULATIONS

ITEM 10 - GOVERNING PUBLICATIONS

For rates, rules, regulations and provisions applicable to the transportation of household goods, in use, except as otherwise specifically provided herein, see Tariff Freight Pa. P.U.C. No. 53 (Carrier Directory No. 53), loose-leaf revisions thereto and successive issues thereof, issued by Tristate Household Goods Tariff Conference, Inc., Agent.

ITEM 20 - CLASSIFICATION OF PROPERTY

Class 1 Shipments are person effects and property used or to be used in a dwelling when a part of the equipment or supply of such dwelling and such other similar property: except that this subparagraph shall not be construed to include property moving from a factory or store, except such property as the householder has purchased with the intent to use in his dwelling and which is transported at the request of, and the transportation charges paid to the carrier by, the householder.

ITEM 30 - DECLARED VALUE

Rates and charges named herein applicable when the value declared by shipper does not exceed sixty (60) cents per pound per article. For method of determining rates when declared value exceeds sixty (60) cents per pound, per article, see Governing Tariff.

ITEM 40 - ADDITIONAL EXPENSES

Any parking fees incurred at the client's origin or destination will be the responsibility of the client and added to the carrier's charges.

ITEM 50 - ADVANCE RESERVATIONS

Advance reservations must be made prior to the service being rendered.

Abbreviations, reference marks and symbols are explained on last page of tariff.

SECTION 1
RULES & REGULATIONS

ITEM 60 - DEPOSIT AND CANCELLATION POLICY

All reservations for full service move jobs require a deposit equal to one hour of the job labor rate. Deposits are fully refundable if the job is cancelled by the client at least 48 hours prior to the scheduled reservation. Deposit for reservations are forfeited if the job is cancelled within 48 hours of the scheduled reservation.

ITEM 70 - HOURLY LABOR RATES

Hourly rates begin from time the vehicle arrives at client's origin address where the goods pickup will take place and ends at the time the vehicle leaves the client's last destination address where goods are unloaded.

ITEM 80 - TRUCK AND TRAVEL RATES

Truck and travel fees are based on a minimum, of one hour travel time from the office to the pickup origin and from the destination back to the office. If this travel time exceeds one hour according to GPS, then the rate is prorated for the additional time.

NOTE 1 - Truck and travel fees are based on a minimum of one hour travel time from the office to the pick-up origin and from the destination back to the office. If this travel time exceeds one hour, then the rate is prorated for the additional time.

NOTE 2 - Minimum hours charges for Transportation and Move Loading and Unloading Labor:

Days other than Sundays and Holidays (any hour): Two (2) hours minimum charge.

Sundays and Holidays (any hour): Four (4) hours minimum charge.

NOTE 3 - Additional truck fees are \$250.00 per truck if as originally quoted. If not quoted and additional truck is needed, there will be no second truck charge unless there are more goods to be moved than what was estimated.

◆ NOTE 4 - Overnight storage fees are \$350.00 per night per truck for the first night. Additional nights after the first night will be charged at a rate of \$500.00 per night per truck.

NOTE 5 - Fuel surcharges published by Tristate Household Goods Tariff Conference, Inc. and approved by the Pennsylvania Public Utility Commission in effect on the day of the move will be applied.

Move or Packing Labor Only - Pricing is the same as the Full Service Transportation Loading/Unloading Move Labor Rates that are shown above
