4. As the crossing is no longer needed, PennDOT has agreed to remove the tracks at this crossing and restore the road surface, at its sole cost and expense, as part of its roadway improvement project on the East Bayfront Parkway.

5. Following removal of the tracks and restoration of the crossing surface, CSXT requests that the subject crossing be abolished.

WHEREFORE, CSX Transportation, Inc. respectfully requests that its Petition to Amend Secretarial Letter be granted, and that crossing DOT No. 918 324 S, be abolished following its removal and restoration of the roadway by the Pennsylvania Department of Transportation.
