Enclosed is a **RATE CHANGE** for the existing exception tariff, **Tristate 54**, Effective August 7<sup>th</sup>, 2023, for **Litemovers.com, LLC (PA PUC Certificate #A-8916211) in Wayne PA.**


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

A flat charge based on one hour at the applicable rates shown in Columns 2 and 3 will be assessed to cover traveling charges to and from the job.

**Berks, Bucks, Lehigh, and Philadelphia Counties:**

A flat charge based on one and one-half hours at the applicable rates shown in Columns 2 and 3 will be assessed to cover traveling charges to and from the job.

**Lancaster County:**

A flat charge based on two hours at the applicable rates shown in Columns 2 and 3 will be assessed to cover traveling charges to and from the job.

▲ **Any Other County:**

Travel charge will be based on actual time required traveling from carrier's terminal to the first point of origin and traveling from the final destination back to the carrier's terminal.
